TOWN OF SHARPSBURG MINUTES OF THE TOWN COUNCIL MEETING

October 23, 2006

A regular meeting of the Sharpsburg Town Council was held Monday, October 23, 2006, at 7:00pm, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Larry Hyde, Council Member; Clay Cole, Council Member; Stan Parten, Council Member; Robin Spradlin, Town Administrator and Donna Camp, Town Clerk. Council Member McElwaney was absent.

Mayor Staley called the meeting to order at 7:00 pm.
